Meta Platforms cookies (Facebook/Instagram) are processed by Meta Platforms Ireland Ltd. (Ireland — EEA) as an independent controller, based on user consent. For any extra-EEA transfers, Standard Contractual Clauses (SCCs) and/or the EU-US Data Privacy Framework (Commission Decision C(2023)4745) apply. The Controller does not independently transfer data to third countries.

5. Data Subject Rights
